ODPRTEGA MEDNARODNEGA ŠAHOVSKEGA TURNIRJA

“15. HIT OPEN 2010”

- 1) Odprti mednarodni šahovski turnir “15. HIT OPEN 2010” prireja Šahovski klub Nova Gorica.

Pokrovitelji so: HIT d.d. Nova Gorica, Agencija M servis d.o.o., Nova KBM d.d., Področje Nova Gorica in Mestna občina Nova Gorica.

Namen turnirja je prispevek h razvoju šahovske igre v Sloveniji in na Goriškem ter promocija sponzorjev in mesta Nova Gorica.

- 2) Turnir poteka v hotelu PERLA v dvorani PINTA od 31. januarja do 6. februarja 2010.
- 3) 15. HIT OPEN 2009 obsega 2 turnirja: A in B. Na **A turnirju** lahko nastopijo šahisti in šahistke s FIDE ratingom **nad 2000**, na **B turnirju** pa vsi ostali šahisti in šahistke brez ali s FIDE ratingom **do 2100**. Poleg pravočasno prijavljenih se lahko naknadno uvrstijo v 1. kolo tudi zamudniki, če se prijavijo organizatorju in glavnemu sodniku najkasneje do 31. januarja ob 19.00. Drugi zamudniki izgubijo vsako zamujeno partijo.
- 4) Igra se po pravilih FIDE, **9 kol po švicarskem sistemu** - dirigrana varianta po ratingu. Pari se določajo z računalnikom.
- 5) **Igralni čas** na igralca je enak na obeh turnirjih: 90 min z dodatkom 30 sekund/potezo od prve poteze do konca partije.
- 6) Turnirja se upoštevata za **FIDE rating**, na A turnirju je možno osvojiti **mednarodne naslove**.

- 8) Preložitve partij ni možna, odsotni igralec izgubi partijo. Igralec mora predhodno sporočiti sodniku, da v naslednjem kolu ne bo igral, sicer bo izločen iz turnirja. Oba originalna zapisa partije se po končani partiji obvezno oddata sodniku. Odda ju zmagovalec, v primeru remija pa igralec z belimi figurami. **Ne velja člen 6. 6. a pravil FIDE - Izguba partija sledi po zamudi 60 minut.**
- 9) **Nagrade:** bruto v EUR – znesek vsebuje davčne obveznosti (- 25 %)

A turnir:

- glavne nagrade: 2.500, 1.500, 1.000, 600, 400, 350
- najboljši do FIDE ratinga 2400: 300, 100
- najboljši do FIDE ratinga 2300: 200
- najboljši do FIDE ratinga 2200: 100

- šahistke: 200, 150, 100
- mladinci (1990 in mlajši): 100, 50
- seniorji (1950 in starejši): 100

B turnir:

- glavne nagrade: 300, 200, 150, 100, 100
- seniorji (1950 in starejši): 75
- šahistke: 75
- mladinci (1990 in mlajši): 75

Nagrade se izplačajo glede na osvojene točke. Glavne nagrade se pri enakem številu osvojenih točk razdelijo tako, da se polovica nagrade razdeli glede na uvrstitev po srednjem Buholz koeficientu, polovica nagrade pa se deli na enake deleže. Vse ostale nagrade se delijo glede na uvrstitev po srednjem Buholz koeficientu. Vsak nagrajenec ima pravico samo do ene nagrade, pri čemer se mu podeli najvišja oz. nagrada iz manjše skupine. Posebne nagrade se izplačajo v celoti, če je v skupini najmanj 5 igralcev, sicer se razpolovijo.

- 10) **Glavni sodnik** turnirja je Dušan Rusjan, mednarodni šahovski sodnik, njegova namestnika sta Matjaž Lovišček, šahovski sodnik FIDE, in Ana Srebrnič, državna šahovska sodnica. Odločitve glavnega sodnika so izvršne.
- 11) **Turnirski odbor**, ki rešuje pritožbe na odločitve sodnika sestavljajo predsednik Mišo Cebalo, 2 člana Siniša Dražić, Duško Pavasovič in 2 namestnika Vojko Srebrnič, Damjan Japelj, ki se izvolijo pred 1. kolom. Pisno pritožbo na sodnikovo odločitev s kavcijo 25 EUR predloži prizadeti igralec glavnemu sodniku najkasneje 1 uro po končani seansi. Turnirski odbor mora o pritožbi odločiti do naslednjega kola. Odločba turnirskega odbora je dokončna. Če je pritožba upravičena, se kavcija vrne.
- 12) V igralni dvorani **ni dovoljeno kajenje in pitje alkoholnih pijač**. Ravno tako **ni dovoljena uporaba mobilnega telefona in ostalih elektronskih naprav**, ki se bo kaznovala s takojšnjo izgubo partije.
- 13) **Turnirski pravilnik** se objavi pred začetkom na oglasni deski. Igralci potrdijo turnirski pravilnik z vpisom na turnir.

TOURNAMENT REGULATIONS

15th HIT OPEN 2010

- 1) The 15th HIT OPEN 2010 open tournament is organized by the Chess Club Nova Gorica.

The tournament is **sponsored** by: HIT d.d. Nova Gorica, Agencija M servis d.o.o., Bank Nova KBM d.d., področje Nova Gorica and the Municipalities of Nova Gorica.

The idea of the tournament is development and popularisation of chess in Slovenia and Nova Gorica and promotion of sponsors and Nova Gorica town.

- 2) The tournament is taking place at the **PINTA Hall** of Hotel PERLA from 31st January till the 8th February 2010.
- 3) The 15th HIT OPEN 2010 tournament consists of two separated tournament groups: A and B. Players with FIDE rating **over 2000** are allowed to play in the **A tournament**. Non rated players and players with FIDE rating **up to 2100** are allowed to play in the **B tournament**. Players and women players can take part in the tournament after filling the registration form. Late players have exceptionally chance to participate the tournament if they have announced their arrival before and register themselves to the Chief Arbiter and organizer till the 19.00 on 31st January 2010. Other late players lose all missed games.
- 4) The tournament is played by FIDE rules, **9 rounds, Swiss system**. Pairs are chosen by computer.
- 5) **Playing time** is 90 minutes with addition 30 seconds for every move.
- 6) The tournament will be **registered at FIDE** for calculation of rating and winning of international titles.
- 7) **Time schedule:**

- 8) The postponing of a game is not possible. The absent player loses the game. The player must in advance notify to arbiter that he will not play in the next round. In other case he will be disqualified. Both formularies with noted game must be given to the arbiter by the winning player, in case of draw by the player with white pieces. **Article 6. 6. a of FIDE rules is not valid for this tournament – Player loses a game after 60 minutes.**
- 9) **Prizes:** brutto in EURO – slovenian tax duties are included in the amount (- 25 %)

A tournament:

- main prizes: 2.500, 1.500, 1.000, 600, 400, 350
- under FIDE rating 2400: 300, 100
- under FIDE rating 2300: 200

- under FIDE rating 2200: 100
- women players: 200, 150, 100
- juniors under 20 (1990 and later): 100, 50
- seniors 100

B tournament:

- main prizes: 300, 200, 150, 100, 100
- seniors (1950 and before): 75
- women players: 75
- juniors under 20 (1990 and later): 75

Prizes are paid according to player's score. In the case of the same score only main prizes are shared 50% regarding score and 50% regarding medium Bucholz, other prizes are shared regarding medium Bucholz. Every player is allowed to get only one prize, the biggest one or the one from the smallest group. Special prizes are paid in full only for groups consisting of least 5 players, otherwise they are divided.

- 10) The tournament **Chief Arbiter** is Mr. Dušan Rusjan, International Arbiter; his deputies are Mr. Matjaž Lovišček, Arbiter FIDE, and Mrs. Ana Srebrnič, Slovenian Arbiter. Decisions of Chief Arbiter are executive.
- 11) **Appeals committee** consists of chairman Mišo Cebalo, 2 members Duško Pavasovič, Siniša Dražić and 2 deputies Vojko Srebrnič, Damjan Japelj. Written appeal with charge of 25 EUR is acceptable till 1 hour after round finishes. The appeals committee must take the decision before the next round. If the appeal is resolved in player good the charge will be returned. The appeals committee decision is final.
- 12) In the playing hall **smoking, drinking alcoholic drinks and use of mobile phone and other electronic devices** are not allowed. Violation of this norm will be punished by losing the game.
- 13) Players agree with this tournament regulations by their participation at the tournament.
